



## SUMMARY ANNUAL REPORT

### FOR COLUMBIA UNIVERSITY GROUP BENEFITS PLAN

This is a summary of the annual report of the Columbia University Group Benefits Plan (Employer Identification Number 13-5598093, Plan Number 515), for the plan year January 1, 2022 through December 31, 2022. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Columbia University has committed itself to pay certain Medical, Prescription, Vision, and Disability claims incurred under the terms of the plan.

#### Insurance Information

The plan has insurance contracts with EmblemHealth Dental, Zurich American Insurance Company, New York Life Group Insurance Company of NY, and Aetna Life Insurance Company to pay certain Dental, PPO contract, Accidental Death and Dismemberment, Paralysis and Coma, Life insurance, Supplemental life, Dependent life, Long-term disability, Statutory disability, and Supplemental Accidental Death and Dismemberment claims incurred under the terms of the plan. The total premiums paid for the plan year ending December 31, 2022 were \$20,744,695.

#### Paperwork Reduction Act Statement
