# SUMMARY ANNUAL REPORT FOR RETIREMENT PLAN FOR SUPPORTING STAFF OF COLUMBIA UNIVERSITY

This is a summary of the annual report for the Retirement Plan for Supporting Staff of Columbia University, EIN 13-5598093, Plan Number 002, for the plan year 07/01/2021 through 06/22/2022. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

### **Basic Financial Statement**

Benefits under the plan are provided by insurance contracts and a trust fund. Plan expenses were \$15,121,663. These expenses included \$508,617 in administrative expenses and \$14,613,046 in benefits paid to participants and beneficiaries. A total of 0 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$0 as of the end of the plan year, compared to \$179,724,870 as of the beginning of the plan year. During the plan year the plan experienced a change in its net assets of -\$179,724,870. This change includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$7,368,137, including employer contributions of \$1,399,753, earnings from investments of \$5,911,891, and other income of \$56,493.

### **Minimum Funding Standards**

An actuary's statement shows that enough money was contributed to the plan to keep it funded in accordance with the minimum funding standards of ERISA.

- 6. Actuarial information regarding the funding of the plan.
