

Template-Based Hires Page 1 Module and Role Overview

The *PAC Template-Based Hires (TBH)* course consists of two modules that provide guidance on how to complete a hire/rehire template. *Page 1* is where employee and position data is entered, and *Page 2* is where the labor accounting portion is entered.

Completion of both modules and the accompanying knowledge assessment available at the end of the *Labor Accounting Page 2* module is required to use the TBH in PAC. A score of 90% or better is required for passing the knowledge assessment.

This module provides you with the information about and guidance through the entry sections on Page 1 of the TBH templates.

Estimated Time to Complete Module: 45 minutes

The *Template-Based Hire Initiator* role is required to create and submit TBH Templates. The *Template-Based Hire Approver* role is required to approve hire/rehire transactions.

The *PAC Template-Based Hires (TBH)* course consists of two modules that provide guidance on how to complete a hire/rehire template. *Page 1* is where employee and position data is entered, and *Page 2* is where the labor accounting portion is entered.

For academic appointments with no clinical role, the clinical data fields are left blank. Used for Student Officers until the simplified template is available.
- The **Hire-Academic** and **Rehire-Academic** are used for academic personnel on the **Morningside, Lamont Doherty Earth Observatory (LDEO), Nevis** and **Manhattanville** campuses. Used for Student Officers until the simplified template is available.
- The **Hire-Admin** and **Rehire-Admin** templates are used to hire or rehire **administrative** positions regardless of campus.

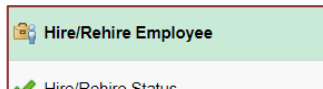

Slide 14 - Academic Appointments and the Rehire Template

Academic Appointments and the Rehire Template

The Academic and Clinical Rehire templates are used to rehire *terminated* employees. If the person is active and being reappointed, other methods are used dependent on the timing, campus, and hire specifics. *The rehire template is not used.*

- The Visa/Contract Renewal module is used to reappointment currently *active academic employees*.
- eComp is used on the Morningside Campus to reappoint faculty, officers of research, and officers of the libraries on cycle from 7/1 to 6/30.
- The Reappointment Roster module (or manual process) is used *reappoint off-cycle academic positions*. Off-cycle reappointments are those that begin on dates other than 7/1, which is the on-cycle effective date.



Non-CUIMC:

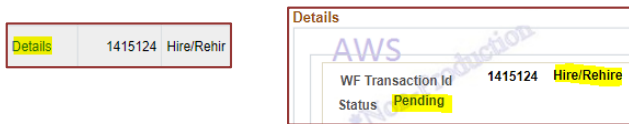
