

Section 1557 “Covered Entities”

Section 1557 of the Affordable Care Act (ACA) prohibits “covered entities” from discriminating on the basis of race, color, national origin, sex, age, or disability in health programs and activities receiving federal financial assistance (FFA). On May 18, 2016, the U.S. Department of Health and Human Services (HHS) Office for Civil Rights (OCR) published a final regulation titled “Nondiscrimination in Health Programs and Activities” implementing ACA section 1557. Columbia University must post the following taglines in at least the top 15 languages spoken by individuals with limited English proficiency in the state or states where the covered entity operates.

Columbia University in The City Of New York, complies with applicable Federal civil rights laws and does not discriminate on the basis of race, color, national origin, age, disability, or sex.

Top 15 languages in New York State:

1 Spanish
