Default Investment Notice**

RE: Columbia University Retirement Plan for Supporting Staff Association

You are receiving this notice to inform you how your contributions under the Plan may have been invested, and how they will continue to be invested if you have not provided the appropriate investment instructions. Contributions under the **Columbia University Retirement Plan for Supporting Staff Association** (the “Plan”) by Columbia University (the “Employer”) may have been invested on your behalf in the default investment fund as described in this notice. This default will only take place if you have selected TIAA as your vendor of choice when you enrolled.

The **Columbia University Retirement Plan for Supporting Staff Association** lets you invest your account in a number of different investment choices. If you do not choose a different investment fund or funds, your plan account may have been invested in a Vanguard Target Date Fund that corresponds to your estimated date of retirement. Each Vanguard Target Date Fund invests in a diversified combination of underlying Vanguard funds, primarily index funds, that provides you with a well-diversified portfolio. The asset mix in these funds gradually and automatically becomes more conservative as you approach your projected retirement date of age 65. If the default investment fund changes at any time in the future, you will be notified.

The enclosed fact sheet for the Vanguard Target Date Funds provides additional information including the investment objectives, risk and return characteristics, and fees and expenses. You can obtain updated information on fees and expenses and a more detailed explanation of the Vanguard Target Date Funds, as well as a list of the Plan’s available funds and a copy of the prospectus at **TIAA.org/columbia** or by contacting TIAA at **800-842-2252**.

You have the right to change the investment allocation of your account at any time by contacting TIAA at **800-842-2252** or accessing your account online at **TIAA.org**.

If you elect to change the investment allocation of your account from one of the Vanguard Target Date Funds, there are no fees or expenses imposed in connection with that transfer. But certain restrictions may apply if multiple transfers are made from any one account during any 60-day period. See the prospectus for more details on restrictions on frequent transfers at **TIAA.org/columbia**.

Distributions from 403(b) plans before age 59½, severance from employment, death, or disability may be prohibited, limited, and/or subject to substantial tax penalties. Different restrictions may apply to other types of plans.
